7 and 8 year olds..... 10:00-11:00 MT Time (2) 1 ½ min Periods  
9 and 10 year olds.....11:00-12:00 Mt Time (2) 2 min. periods  
11 and 12 year olds.....12:00-1:00 Mt Time (2) 2 min periods  
13-14 year olds.....1:00-2:00 Mt Time (2) 2 min periods**

**Referees: We will be using volunteer help, with varsity wrestlers as referees, so mistakes can and will happen. Keep this in mind when coaching. The young refs are doing their best. Treat them like you would like your own son to be treated.**

**Concessions: Will be sold throughout the tournament.**
